#### **Members**

B&R Beurs has a diverse membership base, ranging from near-professional investors to those with a basic interest in investing. Our society is highly international, with members representing over 25 nationalities. While most members study Economics, of our Econometrics, Finance, οг Business Administration, other disciplines such as Law and Mathematics are also well represented. #### Introduction Weekend



## EDUCATION & CAREER

An important part of B&R Beurs is the provision of educational activities and academies as well as career events. These help you in expanding your financial knowledge. This section explains how B&R Beurs offers you these things during the up coming academic year.

#### Academies

B&R Beurs hosts academies during the year for its members. This is the best place to expand your financial knowledge. On Thursdays, lectures are prepared by our Academy Committee to help understand a variety of topics in investing. Furthermore, the last academy of each track is given by a partner in a so called 'professional academy'. In this way, you get to learn the theory behind several investing topics, but also how this knowledge is applied in practice. You as a member are very welcome to attend these lectures, as we want to provide the opportunity to expand your financial knowledge. Also B&R Beurs aims to keep these academies interesting for everyone regardless of your education, experience level or prior knowledge about Finance. The academies are organized by dividing the theory into six essential tracks.

### **Fundamental Analysis**

Learn about the core foundations of a business to decide whether this would be a good investment proposition. You will analyse the underlying value of a security by applying several methods to conclude whether securities are undervalued or overvalued.

#### **Macro Investing**

In this track, you'll learn how macroeconomic factors like interest rates and the business cycle affect financial markets. Moreover, it is discussed how large hedge funds have used this theory to create some successful trades and investment ideas.

#### **Portfolio Management**

Learn how to build a portfolio of individual securities, with a focus on minimizing risk and understanding the key drivers behind your portfolio's returns.

#### **Alternative Investments**

In this track, you'll explore investment opportunities beyond traditional financial markets, with a focus on Private Equity, Venture Capital, and hedge funds. You'll also gain insight into the fundamentals of investing in start-ups.

#### **Derivatives**

Learn about the role of derivatives, futures, and turbos, and discover how incorporating these instruments can enhance your investment portfolio.

#### **ESG Investing**

A relatively new and increasingly important chapter in investing is ESG, which stands for Environmental, Social, and Governance. More and more companies are prioritizing these kind of sustainable investments.

#### **Investors Exam**

After attending the academies, B&R Beurs offers members the opportunity to take the Investor Exam. This exam covers all material discussed during our academies. You can take the exam to display you are serious and ambitious about investing. Note that this exam has been prepared in collaboration with CAIA, a highly respected and recognized educator in the financial industry.

### Workshops

Throughout the year, B&R Beurs also organizes other educational activities to improve your financial knowledge. The Trading & Commodity Trading Days is a popular cycle that teaches you more about the way firms trade, where the workshops vary from algorithmic trading to commodity trading. The Factset Days offer our members the opportunity to learn how Factset helps you to find the appropriate information of a country and sales of a specific firm. Then, several masterclasses and cases are organized throughout the year. Here, partners teach you about relevant topics or problems that they encounter nowadays.

#### Career Support

Alternatively, there is the Career Committee, which is here to assist you with a range of career-related matters. Whether it's professionalizing your CV or writing a compelling motivation letter, they're ready to support you. You can find more information on our website under the Career Development section at bnrbeurs.nl. Members who have used this support found it incredibly valuable when preparing for careers in fields such as Investment Banking, Private Equity, Sales & Trading, and Financial Consulting. # INVESTING 101

Investing plays a central role in the financial sector and is becoming increasingly popular at a personal level. Many are drawn in by stories of wealth and success, inspired by legendary investors like Warren Buffett and Benjamin Graham. Motivated to follow in their footsteps, you open a brokerage account and buy shares of your favorite companies. Then... nothing happens. And that's your first lesson: investing takes time and patience. Your investments might grow around 3% per year, not per week or per day. Investing isn't a get-rich-quick scheme. It's a long-term strategy that rewards consistency and discipline.

How can you achieve more than a 3% annual return? The key is knowledge. Investments should be made with a thorough understanding of the securities (stocks, bonds, etc.) and their underlying value. The essence of investing lies in the relationship between price (the purchase amount) and value (what the security is actually worth). Over time, the price tends to move toward the actual value, which is determined through fundamental analysis.

Fundamental analysis helps you understand the company and its true value. You need to determine if a company is overvalued (price is higher than value) or undervalued (value is higher than price). Key factors include the business model and future earnings. How does the company make money? For instance, McDonald's primarily profits from real estate, not just selling hamburgers. Understanding these aspects helps predict the company's future cash flow, a critical indicator of value.

The value of a company is essentially the present value of its future cash flow. Your job is to estimate this future cash flow to determine the company's intrinsic value. Divide this by the number of shares to find the stock's fair value. If undervalued, you buy the stock (go long); if overvalued, you might consider shorting it.

Shorting involves borrowing the stock, selling it now, and buying it back later at a lower price to return it, profiting from the price drop.

Stock prices can be highly volatile, often without significant news affecting a company's future cash flow. Technical analysis helps predict stock prices based on historical data. It involves identifying patterns such as resistance (price increases before a decline) and support (price declines before an increase).

Investors often label markets as 'bullish' (growth periods) or 'bearish' (decline periods). Bear markets are more volatile, as people tend to trade based on emotions, creating more opportunities for rational investors. Investments range from risky (stocks) to conservative (bonds). Professional investors create diversified portfolios to maximize returns and minimize risks. Diversification involves buying shares of companies th<mark>at are not</mark> st<mark>ro</mark>ngly correlated, reducing the impact of any single security's failure on your overall investment.

A clear example of diversified investing is buying an Exchange Traded Fund (ETF), which tracks a portfolio of stocks. For even broader diversification, carefully determine the proportion of each security in your portfolio.

To summarize, start with fundamental analysis to understand the value of securities, then use technical analysis to time your investments. Aim for an average return of 6% annually. For more in-depth knowledge, attend B&R Beurs academies and read recommended books like A Random Walk Down Wall Street and The Intelligent Investor.


